**Subject:** Miscellaneous Classification Plan Changes



Pursuant to s. 230.09, Wis. Stats., the Administrator of the Division of Personnel Management (DPM) has approved the classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is November 25, 2018.**

- 1) *Modify the **Director of Nursing** classification* to update the definition language as a result of changes made to the Department of Health Services Assistant Director of Nursing allocation and change references from “institution” to “facility.” Reallocations are not necessary for this classification action.
