
Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the following classification plan changes identified in this bulletin. Regardless of the actual notification date, the **effective date is December 5, 2010**, unless otherwise stated.

- 1) *Abolish* the **Revenue Customer Service Representative - Advanced** and *modify* the **Revenue Customer Service Representative – Entry, Developmental, and Objective** classifications **effective December 5, 2010** as a result of a reorganization of the Department of Revenue's Customer Service Bureau which includes the elimination of the vacant advanced leadworker level.
