Pursuant to s. 230.09, Wis. Stats., the Director of the Office of State Employment Relations (OSER) has approved the classification plan changes identified on this bulletin. Regardless of the actual notification date, the **effective date is February 6, 2005**, unless otherwise stated.

- 1) *Abolish* the **Food Scientist** and **Food Scientist-Senior** classifications, **effective February 6, 2005**, as they are no longer being used and *modify* the **Food Scientist-Advanced** classification specification to include the meat position, formerly, the senior level for the Department of Agriculture, Trade and Consumer Protection. - 2) *Modify* the **Administrative Support Assistant** classification specification, **effective February 6, 2005**, to reflect a position movement within the Department of Natural Resources to a different classification. - 3) *Modify* the **Architect/Engineer Supervisor** classification specification, **effective February 6, 2005**, to provide more flexibility for positions in this class to supervise professional architect/engineer positions or a combination of trade and technical bargaining unit employees while performing the duties of an architect/engineer. - 4) *Modify* the **Pharmacist** classification specification, **effective February 6, 2005**, to change the reference of "registered" to licensed" and to update duties to reflect the current duties per licensing requirements. - 5) *Modify* the **Revenue Management Supervisor** classification specification, **effective February 6, 2005**, to indicate changes in allocations at the Department of Revenue as one unit was eliminated, two units combined and three new positions created.
